1	I, HAROLD TORES, declare:		
2	1. I am a patient-member of the Oakland Cannabis Buyers' Cooperative. I have		
3	personal knowledge of the facts stated herein and am of sound mind. If called as a witness, I		
4	could and would testify competently to such matters.		
5	2. I am 59 years old. I was a manager at Delta Dental Plan of California, where I		
6	worked for 25 years until retiring in 1993 because of complications from colon cancer.		
7	3. I was diagnosed with AIDS in 1998. Inhaled cannabis allows me to take my		
8	AIDS medications. I must take about 30 pills per day, which causes extreme side effects.		
9	Cannabis is the only medicine that controls the vomiting. Cannabis also allows me to relax.		
10	4. In 1993 I was diagnosed with colon cancer, for which I underwent chemotherapy.		
11	Inhaled cannabis helped me survive the nausea and vomiting caused by the chemotherapy. In		
12	addition, cannabis baked in brownies helped me release bowel movements.		
13	5. If I did not have a safe dispensary from which to obtain cannabis, I would have to		
14	go to the street in search of medicine. Right after a cannabis dispensary was closed in 1998, I got		
15	robbed in Delores Park in San Francisco as I was looking for medicine. A thief threatened me		
16	with a knife and took all my money. On another occasion during the same time period, a		
17	substance I bought from an anonymous drug dealer injured me. I do not know what the		
18	substance was, but something other than marijuana was in it, and it hurt my throat badly after I		
19	smoked it, causing swelling and pain. In both situations, I do not know who the perpetrators		
20	were and I felt that I could not report my victimizations to the police.		
21	I declare under penalty of perjury under the laws of the State of California that the		
22	foregoing is true and correct.
